



PROMATE 6.0 SERIES WATER SOFTENERS

LIMITED WARRANTY

WaterTree, Inc., warrants to the original consumer purchaser that the ProMate 6.0 Series Water Softener and the parts listed below will be free from defects in material and/or workmanship from the date of the original installation for the following time periods:

- For the **LIFETIME** of the original consumer purchaser: Mineral tanks 6” diameter to 13” diameter and cation exchange resin.
- For a period of **TEN YEARS**: The salt storage/cabinet tank and brine valve.
- For a period of **TEN YEARS**: The Control Valve Body
- For a period of **FIVE YEARS**: The control valve components including electrical parts and internal parts.
- For a period of **FIVE YEARS**: Labor, excluding any trip charges for service calls outside of the normal 10 mile radius service area.
- For a period of **ONE YEAR**: Any other component.
- Any parts used for replacement are warranted for the remainder of the original warranty period.

THIS WARRANTY IS EFFECTIVE TO THE ORIGINAL CONSUMER PURCHASER ONLY AS LONG AS THE PROMATE 6.0 SERIES WATER SOFTENER REMAINS AT THE ORIGINAL INSTALLATION SITE.

No sales representative, distributor, agent, dealer, reseller or any other person is authorized to make any other warranty on behalf of WaterTree, Inc. Upon expiration of the applicable warranty periods, WaterTree, Inc., shall have no further liability related to the products/parts to which the warranty periods apply, except with respect to warranty claims asserted during the appropriate warranty period.

If a part described above becomes defective within the specified period, notify WaterTree, Inc. and arrange a time during normal business hours for us to inspect the water conditioner at the original installation site. Any part found defective within the terms of this warranty will, at WaterTree, Inc.’s option, be repaired or replaced, and as the original consumer purchaser you are responsible for only freight from our factory, any applicable trip charge, and labor (if more than five years after the original installation date).

THIS WARRANTY DOES NOT COVER defects caused by sand, sediment or bacteria fouling, chlorine degradation, accident, fire, flood, Act of God, misuse, misapplication, neglect, alteration, excessive positive or negative water pressure, installation or operation contrary to our printed instructions, or installation, repair

or service by anyone other than WaterTree, Inc., and is extended to the original consumer purchaser only.

Our performance specifications are furnished with each water conditioning unit. Please understand the quality of water supplies may vary seasonally or over a period of time, and that your water usage rate may vary as well. Water characteristics can also change considerably if your water conditioner is moved to a new location. For these reasons, we assume no liability for such variables.

REMEDIES FOR DEFECTS OR FAILURES, TO THE EXTENT PERMITTED BY APPLICABLE LAW, ARE LIMITED TO THE REMEDIES PROVIDED IN THIS WARRANTY.
